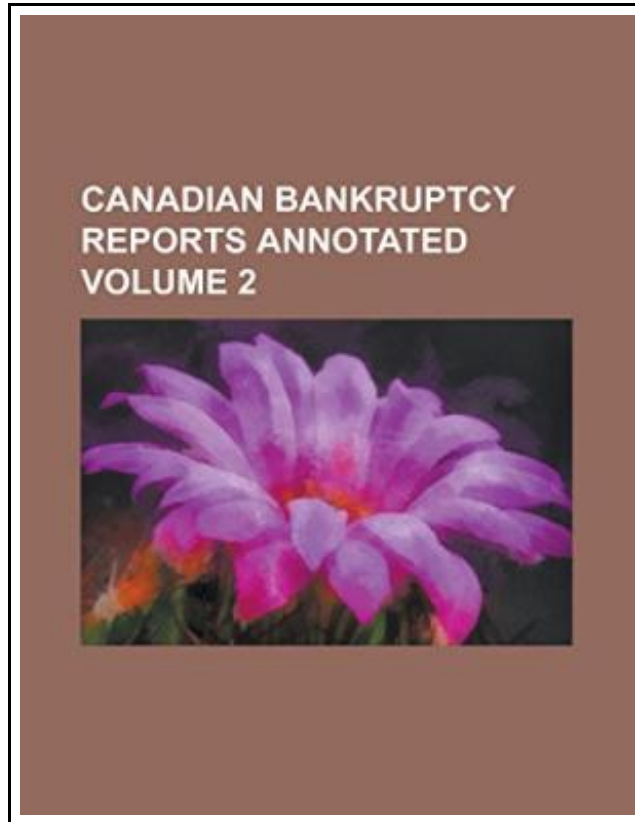

Excerpt: .sale of a new car, the transaction is in effect one of loan to which the Bills of Sale Act, R.S. B.C., 1911, ch. 20, and amendments, would apply if in fact the customer turning in the second-hand car had no dealings with the parties making such advances and if the property in the second-hand car consequently passed directly to the debtor company. The fact that lien notes for deferred payments of the balance on the new car were procured to be signed directly to other persons in whose custody it was warehoused as security for prior advances did not dispense with the necessity for evidencing the security taken upon the second-hand car left in the possession and control of the debtor company by a duly registered chattel mortgage and not by a pretended conditional sale contract which named as the conditional purchaser the actual owner at the time of signing same.
